Joseph Silver is an attorney who focuses his practice on Social Security Disability, Workers' Compensation and Employment law. He represents individuals before state and federal courts and administrative agencies in Pennsylvania, New Jersey and Delaware. He is a member of the Pennsylvania Bar, the National Organization of Social Security Claimants Representatives (NOSSCR) and the Philadelphia Bar Association's Disability Law Committee. He is also a member of the Bicycle Coalition of Greater Philadelphia

Prior to joining Silver & Silver, Mr. Silver reported on law and technology for an online media publication, [Ars Technica](#), focusing on legal issues related to privacy, surveillance, data security, and intellectual property. Mr. Silver has also previously worked for the American Civil Liberties Union, the Electronic Privacy Information Center, and the Future of Music Coalition, trying to improve the digital civil liberties landscape and writing about technology developments. He has also worked as a research and teaching assistant at Washington & Lee University, where his scholarship focused on Cyber Surveillance and Privacy Law.

Mr. Silver received both his Juris Doctorate (2013) and Masters Degree in Media Studies (2013) from Duke University and a Bachelors of Arts Degree from Amherst College (2008), where he studied literature and music. In law school, Mr. Silver worked with Duke's Veteran's Disability Law Project and the school's AIDS Legal Assistance Project, where he helped disabled individuals with Social Security Disability and Veterans Disability benefits applications. He was also an active member of the Duke Law Intellectual Property and Cyberlaw Society and concentrated in technology, intellectual property, and cyber surveillance law and policy.

Hello. In 2005 I earned a degree in Special Education from West Chester University, but never really found my way into a classroom post-graduation as my passion for brewing beer and business led me down a divergent path.

I began brewing in my parent's garage during my senior year of college and quickly began winning awards in the home brewing circuit. Weyerbacher Brewing Company in Easton, Pa hired me as a cellarman in 2006. This meant that I worked 12 hour days and essentially performed the least desirable tasks in the brewhouse (scrubbing mold, filling kegs and bottles, filtration, etc). When I had hit the ceiling for progression at Weyerbacher, I moved on to Iron Hill Brewing Company. Iron Hill was an eye opener for me, as I was intimately involved in every aspect of the brewing/packaging/serving process. During my time at Iron Hill, I enrolled in a number of business classes at the Wharton School of Business as well as the Community College of Philadelphia. After five years at Iron Hill and a number of years perfecting my business plan for Tired Hands, my wife and I purchased an old physician's office located at 16 Ardmore Avenue. Throughout college I worked construction to pay my tuition, so I applied for a General Contractor's license from the township and began renovations on our new building. Eleven months later, we opened the doors to our first facility: Tired Hands BrewCafé. Our Café is capable of housing roughly one hundred and eleven people and for the first three years, we were usually at capacity! Tired Hands quickly garnered a worldwide fan base. We were barely able to keep up with demand for our beer and food... So much so that we began looking for more space in Ardmore within two years of opening our doors.

We rather quickly located one of the only warehouse spaces in Ardmore at 35 Cricket Terrace and began extensive renovations to create our new restaurant/production facility. After thirteen months of renovations, we opened the Fermentaria. The Fermentaria is our first "real" restaurant as well as our production brewery. Via the Fermentaria, we are now able to keep up with demand for our beer and food and curate a more comfortable experience for our guests.

Currently, we sell 90% of our beer production to the Ardmore/Philadelphia region. We also export to New York State, Denmark, and Sweden. We have raised over \$15,000 for charity since opening our doors three and a half years ago.

We value local over imported, small batches over mass production, and striking a successful balance between giving back to our community and personal profit. Localization guides everything we do, from sourcing raw ingredients and materials, to employing area talent.
