# **MEMORANDUM**

- SUBJECT: Belmont Hills Community Center Rear Slope Stabilization Bid Review / Award Recommendation LMT Contract No. 4025-24-19

As requested, we have reviewed the following bid submitted by Joseph J. Danielle, LLC, the apparent low bidder for the referenced project, and are herewith providing our recommendation for award.

Base Bid	\$60,328.03
Contingencies	\$20,318.66
Total	\$80,646.69

By way of background, the project is for the stabilization of the steep slope along the rear parking area for the Belmont Hills Community Center. The slope is abutting a residential property and has eroded over time, undermining accessory structures on the adjoining property. The designed improvements reinforce the toe of slope with a concrete barrier, reduces the severity of the slope by regrading the eroded area, and restabilizes the disturbed area with erosion control matting and seed for hardy vegetative ground cover. We met with the adjoining property owner, and they concur with the planned improvements.

We find the price bid of \$80,646.69 to be reasonable for the items of work required. The bid is \$34,353.31, or 30%, less than the construction budget of \$115,000. Please note the \$20,318.66 of contingencies will only be used if and when directed by the Township.

Therefore, we recommend that the contract be awarded to Joseph J. Danielle, LLC, contingent upon the remainder of the contract requirements being in order. Funds are available through the Capital Projects Fund #4025 - Facilities Improvements Project.
