AN ORDINANCE To Amend The Code Of The Township Of Lower Merion, Chapter 145, Entitled Vehicles And Traffic, Article XV, Schedules, Section 145-114, Schedule XIV: Stopping Or Standing Prohibited, To Amend The Hours Of The "Stopping Or Standing Prohibited" Regulation On The South Side Of Bryn Mawr Avenue From 50 Feet West Of Levering Mill Road West For 166 Feet And From 216 Feet West Of Levering Mill Road West For 326 Feet; And By Amending Section 145-117, Schedule XVII: Parking Prohibited Certain Hours, To Establish A No Parking Regulation On The South Side Of Bryn Mawr Avenue From Academy Road To W. Amherst Road.

The Board of Commissioners of the Township of Lower Merion does hereby enact and ordain:

<u>Section 6.</u> Nothing in this Ordinance or in Chapter 145 of the Code of the Township of Lower Merion, as hereby amended, shall be construed to affect any suit or proceeding in any Court, any rights acquired or liability incurred, any permit issued, or any cause or causes of action existing under the said Chapter 145 prior to the adoption of this amendment.

<u>Section 7.</u> The provisions of this Ordinance are severable, and if any section, sentence, clause, part, or provision thereof shall be held illegal, invalid, or unconstitutional by any Court of competent jurisdiction, such decision of the court shall not affect or impair the remaining sections, sentences, clauses, parts, or provisions of this Ordinance. It is hereby declared to be the intent of the Board that this Ordinance would have been adopted as if such illegal, invalid, or unconstitutional section, sentence, clause, part, or provision had not been included herein.

Section 8. This Ordinance shall take effect and be in force from and after its approval as required by law.
