## AN ORDINANCE

AN ORDINANCE To Amend The Code Of The Township Of Lower Merion, Chapter 145, Vehicles And Traffic, Shall Be Amended To Permit Off-Highway Parking Permits To Be Issued For Daily Periods At A Cost Of \$3 Per Day, For Weekly Periods At A Cost Of \$12 Per Week, For Monthly Periods At A Cost Of \$45 Per Month, And For Six-Month Periods At A Cost Of \$240.

The Board of Commissioners of the Township of Lower Merion hereby ordains:

Section 1. The Code of the Township of Lower Merion, Chapter 145, entitled Vehicles and Traffic, Article XV, Schedules, §145-125, Schedule XXV, Off-Highway Parking Permit Zones; Hours and Fee Schedule, sub-section (C) thereof, shall be amended to provide as follows:

Article XV. Schedules

§145-125. Schedule XXV, Off Highway Parking Permit Zones; Hours and Fee Schedule.

C. Municipal parking permits shall be issued for a six-month period commencing with respect to each district on a date established by the Parking Services Department at a cost of \$240 for each six-month period. The cost will be prorated for the initial offering period only. Municipal parking permits shall also be issued for daily, weekly and monthly periods at a cost of \$3, \$12 and \$45 respectively. Preference will be given to the issuance of six month permits.

Section 2. Nothing in this Ordinance or in Chapter 145 of the Code of the Township of Lower Merion, as hereby amended, shall be construed to affect any suit or proceedings in any Court, any rights acquired or liability incurred, any permit issued, or any cause or causes of action existing under the said Chapter 145 prior to the adoption of this amendment.

<u>Section 3</u>. The provisions of this Ordinance are severable, and if any section, sentence, clause, part, or provision thereof shall be held illegal, invalid, or unconstitutional by any Court of competent jurisdiction, such decision of this court shall not affect or impair the remaining

sections, sentences, clauses, parts or provisions of this ordinance.	It is hereby declared to be the
