As requested, we have reviewed the following bids submitted by the apparent low bidders for the above-referenced project and are herewith providing our recommendation for award. The following are the apparent low bids:

2020 Sanitary Sewer and Storm Lining

SAK Construction, LLC

2020 Manhole Rehabilitation

PIM Corporation

Total for Manhole Contract		\$ 116,540.00
Total for Both Contracts		\$ 567,789.50

We find the price bid of \$451,249.50 for SAK Construction, LLC, and \$116,540.00 for PIM Corporation are reasonable for the items of work required. The total bid for both contracts of \$567,789.50 is \$127,210.50, or 18%, less than the construction budget of \$695,000. Please note the \$26,500 of contingencies will only be used if and when directed by the Township.
