RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF LOWER MERION, MONTGOMERY COUNTY, PENNSYLVANIA (hereinafter "the municipality")

WHEREAS, Section 5 of the Act of January 24, 1966, P.L. 1535, No. 537, known as the "Pennsylvania Sewage Facilities Act," as Amended, and the Rules and Regulations of the Pennsylvania Department of Environmental Protection adopted thereunder, Chapter 71 of Title 25 of the Pennsylvania Code, require the municipality to adopt an Official Sewage Facilities Plan providing for sewage services adequate to prevent contamination of water and/or environmental health hazards from sewage wastes, and to revise said plan whenever it is necessary to determine whether a proposed method of sewage disposal conforms to a comprehensive program of pollution control and water quality management; and

WHEREAS, BL Companies has prepared the "Mount Moro Road Sewer Extension, Minor Act 537 Update Revision", which provides for sewage facilities along Mount Moro Road in the Township of Lower Merion, Montgomery County. The alternative of choice to be implemented is to connect 17 existing residential homes, currently utilizing on-lot sewage disposal systems, to the use of public sewer system via a lower pressure force main and privately-owned and maintained grinder pump unit. The key implementation schedule includes construction of the common low-pressure force main upon receipt of all permits and authorizations, followed by individual lateral connections and decommission of the existing on-lot sewage disposal systems.

WHEREAS, the Township of Lower Merion finds that the proposed common force main extension described in the Sewage Facilities Planning Module conforms to applicable zoning and other municipal ordinances and plans, and to a comprehensive program of pollution control and water quality management.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of the Township of Lower Merion hereby adopt and submit to the Department of Environmental Resources for its approval as a revision to the "Official Sewage Facilities Plan" of the municipality, the above referenced Sewage Facilities Planning Module which is attached hereto.
