AN ORDINANCE To Amend The Code Of The Township Of Lower Merion, Chapter 145 Thereof, Entitled Vehicles And Traffic, Article XV, Schedules, Section 145-115, Schedule XV: “Parking Prohibited At All Times” By Rescinding The No Parking Zones On The East Side Of Ithan Avenue, North From Heatherwood Road South For 500 Feet And On The West Side Of Ithan Avenue, North From Old Gulph Road To 760 Feet South Of Heatherwood Road, And By Establishing A No Parking Zone On Both Sides Of Ithan Avenue, North From Old Gulph Road To Heatherwood Road.

Section 1. The Code of the Township of Lower Merion, Chapter 145, entitled Vehicles and Traffic, Article XV, Schedules, Section 145-115, Schedule XV: Parking Prohibited at All Times, is hereby amended by rescinding the following regulations:

§145-115. Schedule XV: Parking Prohibited at All Times.

<u>Name of Highway</u>	<u>Side</u>	<u>Limit</u>
Ithan Avenue, North	East	From Heatherwood Road south for 500 feet.
Ithan Avenue, North	West	From Old Gulph Road to 760 feet south of Heatherwood Road

Section 2. The Code of the Township of Lower Merion, Chapter 145, entitled Vehicles and Traffic, Article XV, Schedules, Section 145-115, Schedule XV: Parking Prohibited at All Times, is hereby amended by establishing the following regulation:

§145-115. Schedule XV: Parking Prohibited at All Times.

<u>Name of Highway</u>	<u>Side</u>	<u>Limit</u>
Ithan Avenue, North	Both	From Old Gulph Road to Heatherwood Road.

Section 3 Nothing in this Ordinance or in Chapter 145 of the Code of the Township of Lower Merion, as hereby amended, shall be construed to affect any suit or proceeding in any Court, any rights acquired or liability incurred, any permit issued, or any cause or causes of action existing under the said Chapter 145 prior to the adoption of this amendment.

Section 4. The provisions of this Ordinance are severable, and if any section, sentence, clause, part, or provision thereof shall be held illegal, invalid, or unconstitutional by any Court of competent jurisdiction, such decision of the court shall not affect or impair the remaining sections, sentences, clauses, parts, or provisions of this Ordinance. It is hereby declared to be the intent of the Board that this Ordinance would have been adopted as if such illegal, invalid, or unconstitutional section, sentence, clause, part, or provision had not been included herein.

Section 5 This Ordinance shall take effect and be in force from and after its approval as required by law.
