As requested, we have reviewed the following bid submitted by Jaydor Co., the apparent low bidder, for the above referenced project and are herewith providing our recommendation for award.

| Base Bid: 9 OHD (various sizes)             | \$<br>75,995.00 |

| Add Alternate A-2: 11'x23' OHD at Bay 27/28 | \$<br>8,265.00  |
| Add Alternate A-3: 11'x23' OHD at Bay 37/38 | \$<br>8,265.00  |

Each Add Alternate is for replacement of an additional overhead door. We recommend the award of Add Alternate A-1 and A-2. We do not recommend the award of Add Alternate A-3 for budgetary purposes and will replace it under future Phase III.

In summary, we find the total price bid of \$94,415.00 (Base Bid + Contingency + Add Alternate A-1 + Add Alternate A-2) to be reasonable for the items of work required. The bid is \$1,715, or 2%, higher than the construction budget of \$92,700. Please note the \$1,890.00 of contingencies will only be used if and when directed by the Township.

Therefore, we recommend that the contract be awarded to Jaydor Co., contingent upon the remainder of the contract requirements being in order. Funds are available through the Capital Projects Fund #4094 – Overhead Door Replacement / Upgrade Project.
